Cardiovascular Disease (CVD) Risk Reduction

Children who fail to meet UK dietary guidelines have worse cardiometabolic health as young adults

A University of Bristol Policy Briefing that breaks down a study that assessed how well UK school-aged children complied to the UK government dietary recommendations and then correlated these results to prevalence of future heart and circulatory health outcomes. With the aim of informing future policies and strategies to reduce emergence of CVD risk factors early in life.

Conclusions and public health recommendations presented.
